SAN ANTONIO-LEGENDS AND LORE

Here's a little more information about San Antonio.

With the end of the Civil War and the return of the U.S. Army, a variety of buildings in San Antonio were used to house the officers, troops and supplies. It was only after the Army decided to relocate its headquarters to Austin (along with all the associated economic benefits) that the city decided that it was time to make a serious offer. Hoping to lure their return, Mayor W.C.A. Thielepape persuaded the city council to donate a prime parcel of land on a hill overlooking the Northeast edge of town. Fortunately, it worked.

On June 7, 1876, construction was finally begun on ninety-three acres of city-donated land known as Government Hill, according to The Handbook of Texas Online. The contract was with the Edward Braden Construction Company for \$83,900 and \$15,247 for extras. Completed in February of 1878, the Quadrangle became the first structure in what would eventually be known as Fort Sam Houston, an enduring military presence that continues to benefit San Antonio to this day.

Come join in the fun, see the history of the Quadrangle, Ft Sam Houston, The River Walk, the Alamo, and so many other sights. San Antonio is a City you will fall in love with and want to visit again and again.

EAREWELLSSTER MARGARET MARY

Sister Margaret Mary, known to many VLOA members as well as to the hundreds, and perhaps thousands, of Army and civilian personnel stationed at Vinh Long, Vietnam during that long and protracted conflict passed away on 18 May 2002 at Nongkhai, Thailand. She may have been better known as "Mother Superior" of the Good Shepherd Sisters Convent located adjacent to the US Army installation at Vinh Long. Those who knew the Sisters are well aware of the gracious hospitality and friendship that they gave each and every serviceman that entered their pristine compound. In memoriam of Sister Margaret Mary there is no better way than to quote from the "Farewell" as read by Sister Joan Gormley at the burial Mass held in Pattaya, Thailand in tribute to Sister Margaret Mary's remarkable and dedicated life.

"Today we honour the life of Sr. Margaret Mary Brady and give thanks to God for this remarkable woman who remained faithful to her religious vocation for 70 years.

Born the 29th of June 1911 in County Cavan Ireland, one of eight children

Ireland, one of eight children in a Catholic family, she entered the novitiate of the Good Shepherd Sisters in the Mother House in Angers, France, in preparation for her life as a missionary. Her first mission was for a short period in Sri Lanka before being asked to cofound the first Good Community in Singapore. She was a teacher, she used this skill to help many young women in the following years.

During the Second World War, Sr. Margaret Mary and five other

Good Shepherd Sisters, including Sr. Mercy who is now in Nongkhai, and the girls in their care, together with other Religious Groups took refuge in the jungle in Malaysia for one year, as it was too dangerous to be in Singapore at that time. Yesterday, upon hearing that Sr. Margaret Mary had passed away, her former community in Singapore wrote, "We thank God for all she did and was to our community. She was always dear to those of us sisters and girls who recall her happy resounding laughter, that brought cheer to many."

The Good Shepherd Congregation recognized in her, a solid practical faith. Because she could be level headed and brave, she was chosen once again to co-found a new Good

Shepherd Commu-1958. nity in in This time Vietnam. It was in this mission that she first came together with Sister Mary (Hayden), a partnership and friendship that was to last for next 44 years. The joke among us who knew them well was that Sr. Margaret Mary adhered to the rules and Sr. Mary was a nonconformist each was grateful for the complimentary gifts of other. I


was there, with both of them, at the founding and experienced the uncertainties and difficulties of that time but I was always aware of the Sr. Margaret Mary's great kindness and concern for our health and well being. She was a tower of strength. When many of us were frightened, the Vietnam War was not a threat to her. It seemed to us, that she was more concerned that we live our religious commitments faithfully.

She served as superior of our community in Vietnam for 12 years during which time she experienced pains and joys.

Among the Sisters who joined our community was Sr. Ursula from Malaysia. She was killed in a plane crash (USAF C5) during the baby lift in 1975, at the end of the Vietnam War. This was a great tragedy for Sr. Margaret Mary and the Vietnam community. The babies from that tragic crash are buried right here in this cemetery. Life has many twists and turns.

Many young Vietnamese girls joined our congregation. They are scattered now, they are mostly in America. However, there is one representative with us today—Sr. Rosalee. We are very happy she could be here. I am sure that our Vietnamese and Thai Sisters realize that their proficiency in English is partly due to Sr. Margaret Mary's persistence and skill as a teacher.



Looking back at the Vietnam days, I can say that the Sisters, the Vietnamese people with whom we worked and the American soldiers from base near us, honoured and respected Sr. Margaret Mary for her spiritual guidance and kindness. Twenty-five years later, many of the American military men continue to write in gratitude for the solace and sense of normality that the Sisters offered to them during those difficult years. With the Communist Take over in Vietnam, Sr. Margaret Mary had to leave Vietnam. She then spent a short time in Macau. In the late seventies, she came to Bangkok and in 1981 with Sr. Mary (Hayden), Sr. Pranee and I (Sr. Joan) formed

the founding group for our new mission in Nongkhai.

During the past twenty Sr. years, Margaret Mary has not been visibly active in the development work of the good Shepherd Sisters, but it has been here that her solid and dependable presence has given strength to that work. It has emphasized for all of us, the imof portance



'being' for others, not only 'doing.' Her laughter was infectious, her beautiful voice a joy to hear. She constantly delighted in visits from friends and those interested in the work being done.

Today we sing the song Danny boy in her honour. Whenever she was asked to sing that was her song. In Ireland, we say this song is a mother's. It will be Sr. Margaret Mary's farewell to us as we Farewell to her son who is going to battle and continue our Life's journey.

In the last two months, Sr. Margaret Mary grew weaker and was continuously cared for by those who loved her. Her Steadfast faith finally brought her home, into the loving arms of Jesus the Good Shepherd on the morning of 18th May. We remember our beloved Sr. Margaret Mary with love and respect."

For those who desire to make their own independent submissions, as outlined in the above referenced newsletter, it will be necessary to include the *specific applicable unit name in Section II, Item 2 of the Standard Form 180 (SF 180)*. VINH LONG OUTLAWS ASSOCIATION CONSTITUTION

Article I - Name

This Association shall be known as the "Vinh Long Outlaws Association." (VLOA) (The name "Outlaws" was selected as the call-sign identification of the organization upon arrival in Vietnam.)

Subordinate and affiliated units that also had distinctive unit names and call signs (i.e. Mavericks, Roadrunner, Backspin, etc.) will continue to be recognized with their names and will be considered part of the "Outlaws" organization.

Article II - Objectives

The VLOA is dedicated to the following objectives:

- A. To renew and preserve the camaraderie and esprit de corps among members of the VLOA.
- B. To foster, reinforce and perpetuate love of country, respect for the flag of the United States of America and a strong sense of patriotism.
- C. To locate all personnel who were affiliated with the organization during the time frame indicated.
- D. To encourage all eligible personnel who were affiliated with the organization to become members of the VLOA.
- E. To gather data and material of an historical nature and compile and publish an accurate and detailed history of the first year of the organization's existence.

Article III - Operation

- A. The VLOA will operate on a calendar year basis.
- B. The VLOA will operate as a non-profit organization.
- C. A bi-annual audit will be conducted. The audit will normally be performed by two members of the VLOA, not officers of the organization, as selected by the Steering Committee.
- D. In the event of dissolution of this Association, all assets shall be liquidated and all financial obligations of the Association shall be paid. Memorabilia, historical records, photos and other such documents belonging to the Association shall be donated to the U.S. Army Aviation Museum at Fort Rucker, Alabama. Any remaining assets shall be donated to a recognized charity as determined by the Steering Commit-

tee, but under no circumstances shall any member of the Association receive benefit of said assets.

E. No elected or appointed officer of the VLOA will receive a salary or compensation of any kind from the VLOA. All labor and/or personal effort contributions to the VLOA will be voluntary.

Article IV - Reunions

- A. A reunion will be held every other year commencing in 2000 or as otherwise agreed upon by the membership at the previous Reunion session.
- B. Reunions will be held at a time and place to be determined by the Steering Committee. Time and place will be influenced by an informal polling of Association membership.

Article V - Membership

- A. Membership in the VLOA was initially focused on all personnel who were affiliated in any way with the U.S. Army Air Mobile Light helicopter company designated as the 62d Aviation Company (and later redesignated as Company A, 502d Aviation Battalion) and served at any time between August 1964 (the date of initial activation) through September 1965 (ending the units first year in Vietnam.
- B. Notwithstanding the initial time frame for membership, the VLOA will welcome into membership all members of the Outlaws and affiliated units who served with the Outlaws in Vietnam at any later dates when the Outlaws unit was also designated as the 175th Aviation Company.
- C. Membership in the VLOA may be extended to other individuals, at the discretion of the Steering Committee, who have an historical association with the Outlaws.
- D. Membership classifications are General, Active, Honorary, Associate and Life and are described as follows:
- 1. General: Any individual assigned or attached to the Outlaws or any of its attached units during the time frame as outlined in Paragraph V.A, Membership.
- 2. Active: An Active member is any individual who is eligible for membership and who pays a specific amount of dues annually as set by the Steering Committee. (Only Active and Life members are eligible to vote and hold office. All other membership categories enjoy all the benefits of the VLOA except the right to vote and hold office.)

- 3. Honorary: An Honorary membership will be bestowed upon the surviving spouse, parents or child of KIA or deceased members. Other Honorary memberships may be awarded to distinguished persons as determined by the Steering Committee. Honorary members do not pay dues.
- 4. Associate: Associate membership may be made to an individual or organization not actually affiliated with the VLOA, but having a deep and lasting association and/or interest in the VLOA and who pays dues annually.
- 5. Life: Life membership will be made available to an individual eligible for membership and who pays a one-time Life Membership fee as established by the Steering Committee.

Article VI - Organization

- A. The VLOA will have the following officers, which will comprise the Steering Committee:
- 1. Director
- 2. Deputy Director
- 3. Communications Director
- 4. Two members at Large
- 5. Secretary
- 6. Treasurer (Appointed)
- 7. Quartermaster
- B. Holding office or other positions of influence and trust is limited to eligible Active or Life members as defined in this Constitution.
- C. Responsibility and authority of the Steering Committee:
- 1. The Steering Committee shall be the governing body of the VLOA. It shall be responsible for management of the affairs of the Association including funds, programs and regulations. It shall have the authority to approve budgets, authorize expenditures and approve meeting sites and program arrangements.
- 2. A majority of the Steering Committee shall prevail in all matters pertaining to the Association.
- 3. In addition to business conducted at the Reunion, unusual and pressing business may be conducted by the Steering Committee at other times by mail, email or conference calling.
- 4. The Steering Committee may delegate authority and functions to specific members of the VLOA.
- 5. The Steering Committee shall perform such other duties as prescribed by the Constitution and By Laws.

D. Committees:

- 1. The VLOA may have the following standing committees, with duties and responsibilities as defined in Operating Procedures job descriptions approved by the Steering Committee:
- A. Membership
- B. Historical
- C. Reunion
- D. Nominating
- 2. Vacancies for Committee Chairperson will be filled by appointment by the Steering Committee Director.
- 3. Appointments to Committee Chairperson are subject to ratification by the Steering Committee.

Article VII - Voting

- A. Only dues-paying Active and Life members are eligible to vote.
- B. Attending members who are eligible to vote will constitute a quorum for the transaction of business at VLOA Reunions or business meetings.

Article VIII - Constitution and By Laws Amendments

- A. Proposed amendments will be submitted in writing to a Steering Committee member not later than the first day of the Reunion or special session.
- B. Adoption of an Amendment will be by a two-thirds majority of the members present and voting at the Reunion of other business session.

Article IX - Chapters

The formation of local and/or regional chapters is encouraged but shall not be in conflict with the VLOA Constitution and By Laws. The search for former members should be a high priority in local chapter activities.

Article X - Operating Procedures

The Steering Committee will develop an Operating Procedures Manual to ensure that a record is maintained that describes various procedures necessary for the day-to-day operation of the Association. The Manual should be considered a work-in-progress and, as such, will be an informal overview of the operations of the VLOA. The Manual will be maintained in such a manner as to provide a set of guidelines for succeeding VLOA officers and committees.

VINH LONG OUTLAWS ASSOCIATION (VLOA) BYLAWS

Chapter 1 - Members

Membership categories are outlined in the VLOA Constitution. Honorary memberships will be conferred by the Steering Committee for life.

Chapter 2 - Membership Dues

- 1. Eligible members of the VLOA must pay an annual membership fee as determined by the Steering Committee. A Life membership may also be elected by a member after payment of a one time fee as determined by the Steering Committee. A fee structure for Annual and Life memberships will be published in the VLOA Operating Procedures.
- 2. Annual membership fees are due and payable to the Treasurer after January 1st of each calendar year and must be received no later than March 31st.
- 3. Dues-paid members (Annual or Life) will receive each edition of the Outlaw Newsletter as well as be eligible for special promotions that may be offered during the calendar year.
- 4. Non-dues-paid members will receive information announcements regarding upcoming Reunions and will be encouraged to join the VLOA by payment of annual dues.

Chapter 3 - Termination of Membership

- 1. Members of any category may be terminated for cause or conduct contrary to the VLOA standards and best interest. Such termination will be accomplished by the Steering Committee.
- 2. Active membership will be suspended for non-payment of annual dues and the member will revert to the General membership status.

Chapter 4 - VLOA Meetings

- 1. VLOA Steering Committee meetings may be held at any time during the year at the call of the Director and upon the agreement of a majority of the officers.
- 2. A VLOA general membership meeting will be held in conjunction with each VLOA reunion.
- 3. Local Chapter meetings, where separate Chapters have been organized, may be held at any time and/or place as agreed upon by the members of the local Chapter.

- 4. All meetings, sessions or gatherings at which decisions regarding the operation of the VLOA or its local chapters is made by vote, will be governed by the requirements of Roberts Rules of Order.
- 5. A Sergeant of Arms may be appointed by the Director to ensure conformity to governing rules at the Reunion general membership meeting.

Chapter 5 - Election of Officers

- 1. Only Active and Life members may hold elective office.
- 2. The Nominating Committee will develop a slate of candidates who are willing and able to serve as officers of the VLOA.
- A list of nominees will be presented to the membership during Reunion registration. Additional candidates may be nominated by the membership during the Reunion business session prior to the election.
- 3. The Director and Deputy Director will serve for a term of two (2) years. Any person may be nominated for, and reelected to, these positions to serve consecutive terms.
- 4. Members at Large will be limited to a maximum of two (2) two-year terms for a total of four (4) years. The Communications Director will normally serve a two year term but may, at his option, and with the approval of the Director, continue for another two year term.
- 5. Because of the longer term stability inherent in, and the necessity for, the Treasurer's position, the Treasurer, by his personal acceptance and upon ratification of the Steering Committee, will be appointed by the Director and may serve for an unspecified period.
- 6. VLOA officers will be elected during the Reunion business session and will be installed into office at the close of the Reunion.
- 7. Election of officers will be by ballot. Should there be only one candidate for office, the ballot requirement may be waived.

Chapter 6 - Succession of Officers

1. Should the Director resign, become incapacitated or otherwise be unable to serve, the Deputy Director shall succeed him for the remainder of the term. Election for the Director posi-

tion will be held at the next Reunion. The position of Deputy Director will remain vacant until the next election.

2. Should any officer resign, become incapacitated or otherwise unable to serve, the Director will appoint a replacement who will serve until the next Reunion election.

Chapter 7 - Duties of Officers

- 1. The Steering Committee Director will preside at the business meetings of the VLOA and at all Steering Committee meetings.
- 2. The Director may appoint or remove Committee Chairpersons, subject to ratification by the Steering Committee.
- 3. Unless otherwise defined, the duties of Officers will be those customary for such offices.

Chapter 8 - Secretary

- 1. The Secretary shall maintain minutes and records of all official meetings and of decisions made and approved by the Steering Committee.
- 2. Resolutions required by communications means other than regularly scheduled meetings shall be conveyed, in writing, (email) to the Secretary.

Chapter 9 - Treasurer

- 1. The Treasurer will be appointed by the Director and ratified by the Steering Committee.
- 2. Once appointed, the Treasurer will serve in that capacity

for an unspecified period of time.

- 3. The Treasurer will sign checks for debts legally incurred by the VLOA. Debts incurred will be supported with valid vouchers indicating date, dollar amount and specifics of the purchase.
- 4. The Treasurer will submit an annual budget to the Steering Committee to be approved no later than 31 November reflecting expenditures for the next calendar year. The Treasurer will perform other duties customary for the office.
- 5. The Treasurer will provide a quarterly financial statement to the VLOA Steering Committee no later than the 10th of the month following each quarter. The financial statement will be made available to any active member upon request.
- 6. The Treasurer will provide a report to the membership during the Reunion business session.

Chapter 10 - Communications Director

The Communications Director will manage the publication and distribution of the VLOA Newsletter. The Communications Director will be provide information and communications on the VLOA to external agencies as necessary.

Chapter 11 - Quartermaster

The Quartermaster will manage and coordinate the procurement, storage and sale of various items of Outlaw memorabilia and make such items available to the members. The Steering Committee will approve the purchase of such items. Items will be made available to members on a "for-profit" basis in order to supplement VLOA revenue.


